

# REGISTRATION-CONTRACT

## BARCELONA MINIATURAS FAIR 2022

Between Cosa de 3, S.C with VAT number CIF J65657157 (hereinafter the Organization).

And the artisan or exhibitor, acting on his/her own behalf,

Both parties declare an interest to lease a table at Barcelona Miniaturas Show and undertake to observe the following agreement:

FIRST.- The organization leases to the exhibitor as many tables as he/she asks for in the inscription form, with the characteristics and price stipulated in said form. Inscription must be approved by the organization.

SECOND.- Once the inscription is approved, payment will be made by bank transfer to the account **IBAN ES07 1491 0001 2121 3262 4228, BIC TRIOSESMMXXX (Triodos Bank)**, or **Pay pal transfer to [barcelonaminiaturas@gmail.com](mailto:barcelonaminiaturas@gmail.com)** Paypal account, in which case Paypal commissions must be added to the total amount. The exhibitor will not be considered full participant in Barcelona Miniaturas Show until the inscription is fully paid.

THIRD.- The exhibitor gives his/her contact data in the inscription form, which will be used solely and exclusively to send information of everything concerning the organization of the Barcelona Miniaturas Show, and other activities organized by Cosa de 3, S.C. These data will be processed in accordance with the European Union Data Protection Laws and you may exercise your rights by sending an email to [barcelonaminiaturas@gmail.com](mailto:barcelonaminiaturas@gmail.com)

FOURTH.-The Organization will try to promote the show in every possible general media and on social media. The Organization also undertakes to negotiate better accommodation conditions for the exhibitors at the Hotel, insofar as possible, and also to provide sufficient time for set up and dismantling. The exhibitor undertakes to send all the promotional material (pictures, logos, etc.) in the terms provided by the Organization, and to respect the time of set up and dismantling.

FIFTH.- The Organization provides the demanded number of tables, one chair per table, an identifier poster for the table, and one personal badge per table. The tables also have access to outlet plugs.

SIXTH.-The Organization distributes exhibitors according to the space they need and the type of products they sell. However, we will try, as far as possible and in strict order of booking, to respond to requests regarding a particular placement in the room.

SEVENTH.-The exhibitor undertakes to tell the organization if he/she is exhibiting pieces made by another exhibitor not present at the fair, so that we can indicate in our exhibitor list that this second exhibitor will be represented by the first. Exceptionally, and due to COVID safety measures, it is not allowed to share a table.

EIGHTH.- No smoking or alcohol drinking is allowed in the showroom.

NINTH.-It is strictly forbidden to let other individuals or visitors behind the table, due to COVID safety measures. Also, during the Show, it will be mandatory to follow any rules stated by the Health Authorities, such as personal distance, face mask, or hand washing, both for exhibitors and visitors. The Organisation undertakes to inform the exhibitor of any change in this measures.

TENTH.-The Organization will not be responsible under any circumstances for the legal or tax situation of the exhibitor or the person/s sharing his/her table or cooperating with him/her at the Fair.

ELEVENTH.-In case of cancellation:

- a) If the exhibitor cancels his/her participation, the inscription fee will not be returned. If the cause of cancellation is force majeure, with documental proof, the fee will be returned if the cancellation occurs before 12 January 2022. Later than that, it will be counted as a reservation for next year's Show. If the inscription fees were to change, if the amount is higher, the exhibitor will have to pay the difference. If it is lower, the exhibitor will not be entitled to any compensation.
- b) If the Organisation cancels the Show, whether it is due to its own will or to force majeure, the inscription fees will be returned to the exhibitors.
- c) Force Majeure, as stated in the article 1105 of the Spanish Código Civil, is the concurrency or any unpredictable or inevitable fact with any part of the contract, such as war, great alterations of public peace, strikes, natural phenomena with catastrophic effects such as earthquakes, tsunamis, landslides, floods, pandemic or similar ones, if declared as so by the authorities, and particularly if they prevent or make very difficult for exhibitors to stay at or travel to the city where the show will be held.

TWELFTH.-If the show must change its date, or if the circumstances derived from the COVID-19 pandemic and the limitations imposed by the authorities to prevent its spread make extremely complex or excessively burdensome its celebration or the participation of exhibitors, the organisation will offer alternatives and will present them to all exhibitors, so that the majority of them decides what to do. The Organisation entitles to follow their decision.

THIRTEENTH.- In case of discrepancy or breach of this contract, both parties submit themselves to the jurisdiction of the Courts in Barcelona.

FOURTEENTH.-Participating in the Fair implies full acceptance of the present contract.
